- IV.    **APPROVAL OF AGENDA** Motion by Sikowski, seconded by Dama to approve the agenda as presented. Motion carried 7-0.
- V.     **BOARD APPOINTMENT OF ORGANIZATIONAL MEETING CHAIRPERSON**  
Motion by Sikowski, seconded by Deschane to appoint Patrick Mans as the organizational meeting chairperson. Motion carried 7-0.
- VI.    **BOARD ORGANIZATION – ELECTION OF OFFICERS**

  - C.     **CLERK** Motion by Wiedemeier, seconded by Dama to nominate Martha Neitzer as Clerk; motion by Meissner, seconded by Sikowski to nominate Ginger Deschane as Clerk. Motion carried for Ginger Deschane as Clerk 4-3.
  - D.     **TREASURER** Motion by Dama, seconded by Cherry to nominate Thomas Wiedemeier for Treasurer. Motion by Meissner, seconded by Deschane to nominate Martha Neitzer for Treasurer. Motion carried for Martha Neitzer as Treasurer 4-3.
- VII.   **COMMITTEE APPOINTMENTS** Motion by Deschane, seconded by Dama to approve the committee appointments. Motion carried 7-0.

VIII. APPOINT BOARD MEMBER TO ATTEND CESA 8 ANNUAL CONVENTION  
Motion by Dama, seconded by Meissner to appoint Sikowski to attend the CESA 8 Annual Convention. Motion carried 7-0.

IX. DESIGNATION OF BANKS Motion by Deschane, seconded by Meissner to designate Farmers & Merchants Bank & Trust, Bank Mutual, Bank North and Local Government Investment Pool. Motion carried 6-0-1 with Dama abstaining.

X. INTERNAL BOARD POLICY Motion by Dama, seconded by Deschane to approve the internal board policy. Motion carried 7-0.
