a. 2010-2011 BUDGET UPDATE We have $\$ 260,000$ for the 20102011 budget under levy and aid. This will take care of our contract increase for all the staff and fund the additional teacher in SAGE. The 2011-2012 budget will be much different. All the aid from Obama's ARRA Stimulus money will be gone.
