Dear Parent/Guardian,

The Crivitz School District would like to allow our students access to Youtube for educational purposes. Currently YouTube is not accessible by students and in order for us to allow access to YouTube, Google requires our institution to obtain parental consent.

We believe Youtube to be a very powerful educational tool when used in the classroom and throughout your student's learning processes. If you are not familiar with YouTube, YouTube is a free video sharing website that allows any user anywhere in the world to share a video, or view any video publicly shared by another user. As any individual in the world can upload a video to YouTube, videos may be deemed objectionable or inappropriate. The District can apply a strict filtering system that will block objectionable or inappropriate content; however, it must be noted that the filtering system is mechanical and uses logic and algorithms to block the content. As a result, videos may be accessible by your student(s) that the filter didn't classify as inappropriate or objectionable.

In addition to obtaining parental permission, we are to provide parents/guardians with Google's privacy and security information.
